

Art Therapy Studio Pricing Guidelines

Registration fees for our Community Art Therapy programs are to be paid in their entirety, whether you attend all the sessions or not. We do not reimburse or adjust fees for missed sessions.

Full Prices

Individual sessions	\$80 per 1 hour session
10-week long Community Art Therapy groups	\$145-\$195 depending on the group

**Individual Art Therapy Sessions with an Art Therapy Student Intern are not eligible for Financial Assistance.*

Individual Art Therapy Client-Artists will be invoiced for sessions prior to the beginning of the session and must be paid before services are rendered.

Insurance

Unfortunately, we are not able to accept insurance to pay for services at this time.

Financial Assistance

Financial assistance will be determined by a sliding scale based on household income. We offer 50% and 75% fee reductions based on financial need. We use the HHS federal poverty guidelines to determine need. We offer assistance for 10-week CAT/DTA groups and for individual sessions with ATS staff. Please see the chart below to see if you qualify for financial assistance:

All individuals eligible for financial assistance may **only receive the fee reduction toward one 10-week session program per season**. This fee reduction will carry over each registration period in perpetuity unless you communicate to us you no longer need financial assistance.

If you miss 3 days during a 10-week session period, you are no longer eligible for the financial assistance fee reduction.

Self-Registration

Refund & Cancellation Policy for Community Art Therapy Programs

Your payment for registration reserves your spot in the program(s) for which you have signed up to attend. Since we have limited spots available, we have updated our refund policy to encourage individuals who need to cancel to do so in enough time for someone else to fill the open spot. We offer a full money back refund for cancellations up to 7 days prior to the first date of the program(s) in which you are registered to attend. We offer a 50% refund for cancellations up to 3 days prior to the first date of the program(s) for which you are registered to attend. We do not give refunds for registration if you cancel 48 hours (about 2 days) or less before the first date for the program(s) for which you are registered to attend. There are no refunds for session days you do not attend. If Art Therapy Studio needs to cancel a session day, we will do our best to schedule a make-up date which will be offered at the end of the program.

Every Community Art Therapy program has an enrollment minimum of 4 people for the program to run. If the program fails to achieve 4 enrollments a week before the program begins, participants will be notified and offered the option to transfer to another open program or receive a refund.

Refunds will be issued in the method in which the initial payment was received. We do not hold refunds as "store credit" for future registrations. Once you have cancelled your registration your refund will be issued within 24-48 hours (about 2 days).

Cancellations for Individual Art Therapy Sessions

Individual Sessions must be cancelled prior to 24-hours before the scheduled session. If an Individual Session is cancelled in less than 24-hours' notice you will be billed for that session.
